Political Proportionality and Amendments to Appointments to Council Bodies 2025/26

Executive Summary:

This report seeks approval to the revised Political Proportionality for the City Council for 2025/26 and the consequential amendments required to appointments to Council bodies which have arisen as a result of the formal notification that, with effect from 1 August, 2025, Councillor G Lewis has resigned from the Labour Group and that Councillors S Gray, G Lewis and E Reeves have formed the Green and Independent Alliance Group on the City Council.

Recommendation:

That Council:

- 1) Approve the revised Political Proportionality for the City Council for 2025/26, attached as Appendix 1 to this report.
- 2) Approve the following amendments to appointments required as a result of the revised Political Proportionality:-.
 - a) Appoint Councillor M Mutton to the Labour Group place on Planning Committee in place of Councillor G Lewis.
 - b) Appoint Councillor S Agboola to the Labour Group place on the Joint Health Overview and Scrutiny Committee in place of Councillor G Lewis.

- c) Appoint Councillor F Abbott to the Labour Group place on the Health and Social Care Scrutiny Board (5) in place of Councillor G Lewis.
- d) Appoint Councillor G Lewis to the Green and Independent Alliance Group place on the Business, Economy and Enterprise Scrutiny Board (3) in place of Councillor F Abbott.

Report title: Political Proportionality and Amendments to Appointments to Council Bodies 2025/26

1. Context (or background)

- 1.1 At the Annual General Meeting of the Council on 22 May 2025, Council approved the Political Proportionality for the City Council for 2025/26, based on the following Group numbers:
 - Labour Group 40 seats
 - Conservative Group 12 seats
 - Green Group 2 seats
- 1.2 Appointments were made to Council and outside bodies for 2025/26 in accordance with the Local Government and Housing Act 1989 and The Local Government (Committees and Political Groups) Regulations 1990 which require bodies to be politically balanced and seats on Council bodies to be allocated in proportion to the Groups' share of the total membership of the Council.
- 1.3 Subsequently, on 24 June 2025, following the establishment of the Reform UK Group, Council approved the revised Political Proportionality for the City Council for 2025/26 based on the following updated Group numbers and amended appointments to Council and outside bodies accordingly:-
 - Labour Group 40 seats
 - Conservative Group 10 seats
 - Green Group 2 seats
 - Reform UK Group 2 seats
- 1.4 On 1 August, 2025 Councillor G Lewis resigned from the Labour Group and Councillors S Gray, G Lewis and E Reeves formally notified the Proper Officer that they had formed the Green and Independent Alliance Group on the City Council, with Councillor Reeves as the Leader of the Group and Councillor Gray as the Deputy Leader. The revised Group numbers of the Council are now:-
 - Labour Group 39 seats
 - Conservative Group 10 seats
 - Green and Independent Alliance Group 3 seats
 - Reform UK Group 2 seats
- 1.5 In accordance with the Local Government and Housing Act 1989 and The Local Government (Committees and Political Groups) Regulations 1990, consideration needs to be given the revised Political Proportionality of the Council and to consequential amendments to the appointments to Council bodies for 2025/26. No changes are required to outside bodies.

- 1.6 The revised Political Proportionality for 2025/26 is attached as Appendix 1 to this report for approval at the meeting of the City Council on 2 September, 2025.
- 1.7 Following consultation with the Groups, the consequential amendments to appointments are detailed in paragraph 2 below

2. Options considered and recommended proposal

Council is recommended to:

- 1) Approve the revised Political Proportionality for the City Council for 2025/26, attached as Appendix 1 to this report.
- 2) Approve the following amendments to appointments required as a result of the revised Political Proportionality:-.
 - a) Appoint Councillor M Mutton to the Labour Group place on Planning Committee in place of Councillor G Lewis
 - b) Appoint Councillor S Agboola to the Labour Group place on the Joint Health Overview and Scrutiny Committee in place of Councillor G Lewis
 - c) Appoint Councillor F Abbott to the Labour Group place on the Health and Social Care Scrutiny Board (5) in place of Councillor G Lewis.
 - d) Appoint Councillor G Lewis to the Green and Independent Alliance Group place on the Business, Economy and Enterprise Scrutiny Board (3) in place of Councillor F Abbott.

The Group Leaders have been consulted on the appointments relevant to their Group.

Amendments to appointments to Council bodies will take effect from the date of the Council meeting.
