# Report title: Political Proportionality and Amendments to Appointments to Council and Outside Bodies 2025/26

# 1. Context (or background)

- 1.1 At the Annual General Meeting of the Council on 22 May 2025, Council approved the Political Proportionality for the City Council for 2025/26, based on the following Group numbers:
  - Labour Group 40 seats
  - Conservative Group 12 seats
  - Green Group 2 seats
- 1.2 Appointments were made to Council and outside bodies for 2025/26 in accordance with the Local Government and Housing Act 1989 and the Local Government (Committees and Political Groups) Regulations 1990 which require bodies to be politically balanced and seats on Council bodies to be allocated in proportion to the Groups' share of the total membership of the Council.
- 1.3 On 6 June, 2025 Councillors J Gardiner and M Lapsa formally notified the Head of Governance, as the Proper Officer, that they were now Reform Councillors (instead of Conservative Councillors) and had formed the Reform Group on the City Council, with Councillor Gardiner as the Leader of the Group and Councillor Lapsa as the Deputy Leader. The revised political make up of the Council is now:-
  - Labour Group 40 seats
  - Conservative Group 10 seats
  - Green Group 2 seats
  - Reform Group 2 seats
- 1.4 In accordance with the Local Government and Housing Act 1989 and The Local Government (Committees and Political Groups) Regulations 1990, consideration needs to be given the revised Political Proportionality of the Council and to consequential amendments to the appointments to Council and outside bodies for 2025/26. The revised Political Proportionality for 2025/26 and the consequential amendments to appointments will be presented to the City Council for approval at the meeting on 24 June, 2025.

# 2. Options considered and recommended proposal

Council is recommended to:

- 1) Approve the revised Political Proportionality for the City Council for 2025/26 which will be presented at the meeting.
- 2) Consider any amendments to appointments to the Council and outside bodies required as a result of the revised Political Proportionality, which will be moved at the meeting.
